Title: Elder Victims Mobile Counselor

Position Summary: The Elder Victims Mobile Counselor will facilitate individual, couples, family, and group

counseling/ therapy services for the Elder Victim Mobile Services (EVMS) program. Clients include any victim of a crime who is age 60 and older living in Montgomery County, Pennsylvania. Counseling services will be conducted in home, community, or office settings, depending on the needs of the client. Counseling will use a trauma-informed lens and utilize multiple modalities such as CBT (Cognitive Behavioral

Therapy), CPT (Cognitive Processing Therapy), and other evidenced-based approaches that will effectively address the clinical trauma symptoms resultant from victimization.

Duties & Responsibilities:

- Develop strategies to identify clients who have been victimized and are in need of services
- Attend various community events and develop/ deliver presentations to promote awareness of TLC's Elder Victims Mobile Counseling services
- Develop a treatment plan consistent with effective strategies to address the current needs and symptoms of clients
- Provide individual, family, and group counseling/ therapy services to clients in the home, community, and/or office settings
- Monitor the progress of each client through by maintaining appropriate case records
- Oversee gathering and reporting of data as required by contracts, grants, or certifying bodies
- Enter all documentation of direct and indirect services into ETO (Efforts to Outcomes) within five business days from the service
- Conduct pre/post assessments and input data into HIPPA compliant survey software
- Advocate for individuals and family members with community and/ or multitreatment team supports, such as health care professionals, legal personnel,

- service agencies, county departments, and others who are in a position of supporting the client(s) receiving services
- Facilitate inter-organizational cooperation with community agencies, schools, county services, healthcare professionals, and community groups
- Attend all required education/ training on topics relevant to victims of crime and trauma-informed interventions to best serve elderly victims
- Attend Foundational Institute training and Pathways training as required by the Pennsylvania Commission on Crime and Delinquency (PCCD)
